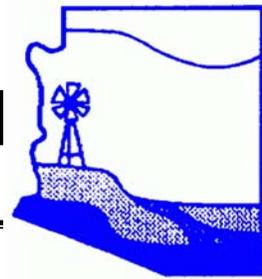

## Viewpoint: Happy New Year!

The year 2008 has arrived with a bang (at least in my neighborhood there were fireworks), and once again New Year's resolutions were in vogue. Lucky readers, I'm not going to offer any smarmy resolutions, but I am going to review some of the events that the Arizona Hydrological Society put on last year and future successes that lie ahead.

One of the biggest events of the year was the 2007 Regional Symposium in Tucson. Were you there? Seemed like a large chunk of the water community was. Over 570 people showed up, but it seemed like more at some of the most popular discussion forums. AHS co-sponsored the event with Southwest Hydrology, a strategy which worked. Gary Burchard and Betsy Woodhouse took a real risk by holding the Symposium at such a grand venue, but it paid off—everyone had a good time and heard a lot of good talks.

Close on the heels of that event was the hugely successful International Symposium on Managed Aquifer Recharge (ISMAR6). Doug Bartlett and Barbara Murphy carried the organizational load for an event that saw attendees from 21 different countries. And again, the expensive venue (Pointe South Mountain) was a big risk, but it all came together at the last minute to create a spectacular event.

Tucson Chapter hosted two lectures by leading hydrologists at the University of Arizona, which remains a big draw for national tours like the Darcy and Kisiel lecture series.

Phoenix Chapter put on a great one-day symposium on all aspects of soil gas. The event raised money to support the Hermann Bouwer Internship scholarship. Almost 80 people showed up, thanks to good organizing by LeeAnna Walker, Ted Lehman, and Beth Proffitt.

Flagstaff Chapter (mostly Dana Downs-Heimes and Erin Young) organized two highly informative field trips, one west to Camp Navajo at Bellemont and the other up the mountain to the Inner Basin well field. If you didn't see the pictures, look at back issues of your *AHS Newsletter* on this site; it will remind you of why the "field" part of field trip is so great.

And planning is already underway for

future AHS events! The 2008 Symposium will be a joint meeting with the American Institute of Professional Geologists, general chair Barbara Murphy. We have already secured the newest and biggest convention venue in Flagstaff at a remarkably reasonable rate, thanks to our co-chairs David Best and Aregai Teclé, both professors at NAU. September 2008 promises one of the best events ever, with fantastic field trips, top-flight talks, and networking opportunities not to be missed.

Planning for the 2009 Symposium is also under way, with our co-hosting organization, the American Institute of Hydrology. Ted Lehman heads up the planning committee. The venue selected, the Westin Kierland resort in Scottsdale, gave us a good deal on the rate, and the luxurious setting should make for another excellent symposium! The Phoenix Chapter is also planning another one-day event in May focused on surface water—look for announcements soon. And watch for information from the Tucson Chapter regarding a field trip to Kartchner Caverns on March 22nd.

We had great events in 2007, and 2008 looks just as good. Solid planning for the future replaces grandiose resolutions for AHS—the only resolution you need to make is to plan to attend the events now being shaped. You won't regret it!

## TUCSON CHAPTER NEWS

Sharon Megdal, of the University of Arizona Water Resources Research Center, will be the presenter on February 12, at the offices of Errol L. Montgomery & Associates, 1550 E. Prince Road at 7:30 p.m. Social half-hour will begin at 7:00 p.m. Ms. Megdal will be speaking about work currently being done at the WRRC (research, education and outreach) and some of the broader efforts of the University of Arizona related to water. ### December Meeting Summary

On December 11, Tim Fitzpatrick from Laboratory Data Consultants (LDC) spoke about the custom Data Management System tools that his company provides to those who work with environmental data. About 15 years ago, LDC started out as a 3<sup>rd</sup> party data validation firm, and then in the late 90's, they started writing their Automated Data Review (ADR) program, which was first used by the Sacramento District of the US Army Corps of Engineers. This program was designed to automate, streamline and validate 100% of their data to be uploaded into an environmental database.

Building on their success of the ADR program, LDC went on to develop more tools that work with ADR. For example, ADR has the ability to produce quickly reports of qualified data. LDC developed their LDC

Project Management System (LPMS), which is a Document Management Tool that resides on the Internet to store all documents, maps, and graphs. But LPMS is more than just a place for file storage. It allows different people to check out documents for editing and keeps an audit trail of the document versions. It also has built-in email alerts for document handling notification and a discussion board. However, LDC's latest development is the slick Environmental Database Management System Internet (EDMSi), which is a Data Storage and Management Tool that users can interface with programs on their PC, but it ultimately resides on a secure server web-based database. EDMSi interfaces with ADR, but improves the way that one can view and share environmental data. EDMSi is built on EQuIS 5's platform and is fully integrated with useful 3<sup>rd</sup> party software products such as ArcGIS, Surfer, LogPlot, RockWorks, GMS, and EVS. Reports can be automated and emailed in various forms to those who need to receive them. Data also can be exported into various formats such as tab-delimited, Excel, ArcGIS shapefiles, or Google Earth. Tim demonstrated some of EDMSi's capabilities with a 3D "flyby" showing a rotating view of an aquifer with wells, a Surfer output of groundwater flow vectors, a plume delineation, and a surface layer. He also showed how quickly one could generate a query from the database, create a cross-tab query from the results, and export pie-charts of the results onto a Google Earth map of a single contamination site.

These capabilities, however, do come at a cost. LDC does provide different levels of tools, capabilities, and customization at a scalable cost, so one does have to weigh the usefulness of the different tools for their business purposes. They also share their code to those who purchase their software in order allow for in-house custom queries and forms. This is nice because you do not feel that your data is held hostage by proprietary code. To find out more information about LDC's tools, visit their website at <http://www.lab-data.com/>.



### The Water Resources Research Center announces the release of a new publication: The Layperson's Guide to Arizona Water

As part of its ongoing effort to serve the water education needs of Arizona citizens, the Water Resources Research Center teamed up with the Water Education Foundation of Sacramento, California, to produce the Layperson's Guide to Arizona Water. The guide meets a longstanding need, offering information about state water issues in a single, reader-friendly publication. The guide is aimed at a wide audience including new arrivals to our rapidly growing state who need to learn about our water ways; long-time residents seeking an up-to-date refresher on current water issues; water professionals wanting a quick reference; policy makers looking for a reliable summary of water facts and information; and the water-interested citizen desiring to learn more about this important topic. Written in the language of the layperson, the guide describes the state's physical setting, provides a history of Arizona's water resource development and explains the legal framework of water management. This provides the basic background for discussions of the major water issues confronting Arizona today. A helpful glossary and list of additional resources is included.

Collaboration between the Water Education Foundation and the WRRC enabled the WRRC to offer the Layperson's Guide to Arizona Water free online, as a public service.



Floodplain ecosystems are influenced by fluvial processes in current and previous climatic cycles. In the southeastern United States, floodplain ecosystems consist predominantly of bottomland hardwood forests and other associated wetlands, rivers and streams, and agricultural/urban areas. These ecosystems provide numerous ecosystem services to society including wildlife habitat, carbon storage, timber products, and water quality enhancement. There is tremendous diversity in the structure and function of floodplain ecosystems across the region. Hydrologic and geomorphic alterations, agricultural practices, water quality and availability, and urban development continue to challenge restorationists and managers at multiple spatial and temporal scales. These challenges are exacerbated by high natural variability in floodplains and the prospect of climate change. A critical evaluation of current natural resource restoration and management practices is needed to ensure the sustainability of floodplain ecosystem functions.


